Terms and Conditions of the "Black Friday" Promotional Campaign organized by europa.jobs

1. General Provisions

- 1.1. **Organizer**: The organizer of the campaign is europa.jobs, based in Wrocław, ul. Nenckiego 136A (hereinafter referred to as the "Organizer").
